# FUH: Follow-Up After Hospitalization for Mental Illness



## Members 6 years of age and older

Who were hospitalized for treatment of selected mental illness or intentional self-harm diagnoses and who had a follow-up visit with a mental health practitioner. Two rates are reported:

- The percentage of discharges for which the member received follow-up within 7 days of discharge. Codes to identify follow-up visits (must be with mental health practitioner)
- The percentage of discharges for which the member received follow-up within 30 days of discharge.

- Ensure appropriate coding to capture services provided within the appropriate timeframe...

# IET- INITIATION AND ENGAGEMENT OF ALCOHOL AND OTHER DRUG ABUSE OR DEPENDENT TREATMENT

Measure evaluates the percentage of adolescent and adult members with a new episode of alcohol or other drug abuse or dependence (AOD) who received:

- Initiated dependence treatment within 14 days of their diagnosis
- Continued treatment with 2 or more additional services within 34 days of the initiation visit

For the follow up treatments, include an ICD-10 diagnosis for Alcohol or Other Drug Dependence from the Mental, Behavioral and Neurodevelopmental Disorder Section of ICD-10 along with a procedure code for the preventive service, evaluation and management consultation or counseling service (see codes below).

## To improve HEDIS scores:

- Ensure adolescent and adult members with a new episode of alcohol or other drug abuse or dependence receive initial dependence treatment within 14 days of diagnosis.
- Ensure members remain adherent to treatment by scheduling 2 or more additional services within 34 days of the initiation visit.
- Ensure appropriate coding to capture services provided within the appropriate timeframe.

#### **AMM- ANTIDEPRESSANT MEDICATION MANAGEMENT**

Measure evaluates the percentage of members 18 years of age and older who were treated with antidepressant medication, had a diagnosis of major depression and who remained on an antidepressant medication treatment. Two rates are reported.

- Effective Acute Phase Treatment. The percentage of members who remained on an antidepressant medication for at least 84 days (12 weeks).
- Effective Continuation Phase Treatment. The percentage of members who remained on an antidepressant medication for at least 180 days (6 months).
- For the follow up treatments, include an ICD-10 diagnosis for Alcohol or Other Drug Dependence from the Mental, Behavioral and Neurodevelopmental Disorder Section of ICD-10 along with a procedure code for the preventive service, evaluation and management consultation or counseling service (see codes below).
