ADHD MEDICATION FOLLOW-UP CARE



The percentage of children ages 6-12 newly prescribed an ADHD medication that had at least three follow-up care visits within a 10 month period, one of which was within 30 days of when the first ADHD medication was dispensed. The visit should be with a practitioner with prescribing authority. Two rates are reported: Rate 1- Initiation phase and Rate 2- Continuation and Maintenance Phase

INITIATION PHASE

One face-to-face outpatient follow-up visit with a prescribing practitioner within 30 days after the date the ADHD medication was newly prescribed.

CONTINUATION AND MAINTENANCE PHASE

Members 6-12 years of age who remained on the dispensed ADHD medication for at least 210 days and in addition to the visit in the Initiation Phase, had at least two follow-up visits with a practitioner within 270 days after the Initiation Phase ended. One of the two visits may be a telephone or telehealth visit with the prescribing practitioner.

CODES TO IDENTIFY VISITS: Any code noted above in the initiation phase or one of the following. Note: Only one of the two visits (during days 31–300) may be a telephone visit (Telephone Visits Value Set) or a telehealth visit.

Treating ADHD:

Children age 6 - 12 years old with a new diagnosis of ADHD must have a visit on or 30 days after prescription initiation and 2 more visits by 10 months.

To improve HEDIS scores:

- Prescribe a quantity of less than 30 pills to ensure member returns by 30 days
- Schedule a two week follow-up to check member and ensure return by 30 days
- Schedule a 6 week, 3 month and 6 month visit to ensure child has at least 2 visits in 10 months
