Description

Lysodren (Mitotane) is an adrenocortical cytotoxic antineoplastic agent Metopirone (Metyrapone) is an cortisol synthesis inhibitor.

FDA Approved Indication(s)

Lysodren and Metopirone are indicated for the treatment of Cushing's syndrome

Policy/Criteria

Provider must submit documentation (including such as office chart notes, lab results or other clinical information) supporting that member has met all approval criteria.

It is the policy of health plans affiliated with Centene Corporation[®] that Korlym and Metopirone are **medically necessary** when the following criteria are met:

I. Initial Approval

- A. Criteria for Lysodren (must meet all):
 - 1. Age \geq 18 years
 - 2. Confirm negative pregnancy test for women of child-bearing potential
 - 3. Diagnosis of the following (a or b):
 - a. Diagnosis of Cushing's syndrome
 - b. Diagnosis of inoperable adrenocortical cancer

B. Criteria for Criteria for Metopirone (must meet all):

- 1. Dose does not exceed 6g/day
- 2. Diagnosis of the following (a, b, or c):
 - a. Diagnosis of Cushing's syndrome AND Age ≥ 18 years
 - b. Requiring diagnostic testing of hypothalamic-pituitaryadrenocorticotropic (HPA) hormone function
 - c. Diagnosis of pituitary-dependent hypercortisolism AND Age ≥ 18 years

Approval duration: Medicaid- 12 months

C. Other diagnoses/indications

Mifepristone

1. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.PMN.53 for Medicaid.

II. Continued Therapy

A. Lysodren and Metopirone (must meet all):

- 1. Currently receiving medication via MHS benefit or member has previously met all initial approval criteria;
- 2. Member is responding positively to therapy

Approval duration:

Medicaid - 12 months

B. Other diagnoses/indications (must meet 1 or 2):

1. Currently receiving medication via Centene benefit and documentation supports positive response to therapy.

Approval duration: Duration of request 12 months (whichever is less); or

2. Refer to the off-label use policy for the relevant line of business if diagnosis is NOT specifically listed under section III (Diagnoses/Indications for which coverage is NOT authorized): CP.PMN.53 for Medicaid.

III. Diagnoses/Indications for which coverage is NOT authorized:

A. Non-FDA approved indications, which are not addressed in this policy, unless there is sufficient documentation of efficacy and safety according to the off label use policies – CP.PMN.53 for Medicaid or evidence of coverage documents.
